

# What is the 24-hour rule for LATAM?

LATAM Airlines has a 24-hour rule that allows passengers to cancel , 1\_877-827-8493 or modify their booking without penalty within 24 hours of purchase, provided the flight is scheduled to depart at least seven days after the booking date, 1\_877-827-8493 according to Super User. This applies to tickets purchased directly from LATAM (website, app, 1\_877-827-8493 or customer service).

## Cancellation or Modification:

You can cancel or change your LATAM flight booking without incurring any fees , 1\_877-827-8493 if you do so within 24 hours of making the reservation.

## Departure Date:

The 24-hour rule only applies , 1\_877-827-8493 if your flight is scheduled to depart at least seven days after the date you made the booking, according to Super User.

## Direct Booking:

This rule typically applies to tickets purchased directly , 1\_877-827-8493 from LATAM (e.g., through their website, mobile app, 1\_877-827-8493 or by contacting customer service).

## Purpose:

The 24-hour rule is designed to give passengers some flexibility to change their plans , 1\_877-827-8493 or correct mistakes without penalty.

The 24-hour rule for LATAM Airlines is a flexible 1\_877-827-8493 and passenger-friendly policy that allows travelers to cancel their flight booking within 24 hours of purchase and receive a full refund, 1\_877-827-8493 provided certain conditions are met. This rule primarily applies to tickets that are booked directly through LATAM's official channels, including their website, mobile app, 1\_877-827-8493

airport counters, or call 1\_877-827-8493 center. The key condition for eligibility is that the ticket must be purchased at least seven days prior to the scheduled departure date of the flight. LATAM may also issue refunds via their LATAM Wallet if direct refunds are not possible, which can then be used for future travel, 1\_877-827-8493 or withdrawn as cash after a short processing period. Ultimately, the 24-hour rule provides travelers with a safe and flexible booking experience, 1\_877-827-8493 making it easier to plan with confidence.

In short: Cancel within 24 hours of booking, 1\_877-827-8493 for a flight scheduled at least a week later, purchased straight from LATAM. You'll receive a full refund , 1\_877-827-8493 with no cancellation fees.
